Full Paper – Author Guidelines

The authors should adhere to the given guidelines when preparing a full paper to be submitted to the AIRC 2022. Early submission is encouraged as it helps us to manage the review process in a timely manner.

Please note that paper submission guidelines should strictly be followed by authors. Author (s) should affirm that the material has not published previously.

Reference	Strictly follow APA style	

PAPER LAYOUT:

The manuscript should be prepared in A4-size. Leave 0.75-inch margins on top and bottom,

and 1.0-inch margins on left and right. Organize the body text in two columns, with a 1.0 line

spacing. Insert and layout figures, tables, and their captions directly in the body text.

TYPESCRIPT:

The manuscript should be written in English, using Times Roman of 10.5-point font size.

LENGTH:

The length of full-papers is recommended to be between 6 to 12 pages of A4-size. The

maximum length of papers should not exceed 6 pages including spaces, figures, tables and

references.

TITLE PAGE:

The first page of the manuscript must contain the paper title, author full name(s), position(s),

and affiliation(s), and contact author's name, affiliation, address, phone number, and email

address. Major words (nouns, verbs, adjectives, adverbs, and pronouns) in the title should be

capitalized. Authors are highly recommended to use the full-paper template provided below.

(Preferred format is MSWord. Other formats are not acceptable)

ABSTRACT AND KEYWORDS:

An abstract and keywords should be included on the title page. The abstract should not exceed

250 words and the keywords of up to five words should be carefully selected to facilitate

readers' search.

MAJOR SECTIONS AND HEADINGS:

Major section headings, including Abstract, sections (1, 2, 3, ...), sub sections (1.1, 1.2). The

paper should involve at least the following major sections:

Example:

Introduction: Describe the motivation and purpose of the research.

Literature Review: Provide a summarised and updated review of literature pertaining to

the key arguments of study.

Methods: Provide sufficient information to allow readers to repeat the work.

Results and discussion: Present the major results and discuss the key points.

Conclusions and Recommendation: State conclusions concisely and without

interpretation.

HYPOTHESES

State each hypothesis that you tested fully and separately. Give it a distinct number (Hypothesis

1) or number-letter (Hypothesis 1a) label.

Examples:

Hypothesis 1a: There is a positive correlation between the availability of hours for work

and the productivity of employees.

Hypothesis 1b: Worker satisfaction increases worker productivity

STATISTICAL SIGNIFICANCE

When statistical significance is explored, report significance levels in separate footnotes placed

in a stack under your regular Table footnotes.

EQUATIONS

Your equations should be numbered consecutively with numbers in brackets on the right. **Do**

not use Print Screen or jpg format.

FOOTNOTES

Use footnotes, not endnotes, whenever necessary. Footnotes should match with a superscript

number at the end of the sentence referencing the source. You should begin with "1" and

continue numerically throughout the manuscript.

TABLES:

Insert tables in the text body. Number the tables consecutively with Arabic numerals, e.g.,

Table 1. and Table 2. Please ensure Tables fit between the margins and are referenced in

the text. Please do not use the words like "in the above Table" or "Table below" or any

other reference of directionality throughout the text. Tables should be in editable format.

Example:

Table 1: Caption (Times New Roman, 12pt, bold and centred)

FIGURES:

Insert figures in the text body. Number the figures consecutively with Arabic numerals, e.g.,

Fig. 1. And Fig. 2. It is preferable to paste images into your document as .gif or .jpg format.

Please ensure Figures fit between the margins and are referenced in the text. Do not use the words like "in the above Figure" or "Figure below" or any other reference of directionality throughout the text.

PAGINATION AND RUNNING HEADLINES

The page numbering will be done by the University after compilation of all the papers. Authors should not type the page numbers and the running headlines.

PERMISSIONS:

The author is responsible for obtaining permission to reproduce in his/her manuscript any copyrighted material. Author is also responsible for obtaining permission to publish the paper from any relevant authority if clearance is required by such authority.

TRANSFER OF COPYRIGHT:

Each contributor will be asked to transfer the copyright of his/her paper to the University. By submitting the paper, it is understood that the authors have agreed to transfer the copyrights to the University through the Symposium Organizer.

CITATIONS

These are your in-text, in parentheses, identifications of other research. Every work that has a citation needs to have a corresponding reference (see "References," below). Citations of papers should include the name(s) of author(s) and the year of publication, e.g., Silva (2021) or (Silva, 2021). References to papers with more than two authors should be in the form of the first author's name followed by 'et al.'-, e.g., Perera et al. (2019) or (Perera et al., 2019). For multiple citations of publications by the same author in the same year append a letter after the date to distinguish different citations.

REFERENCES:

APA referencing System is used. References in the text should be quoted in the following manner:

Authors should make certain that there is a complete reference for every citation in the text. For more detail about APA style, check the website http://www.apastyle.org/.
