## **Items of Discussion**

The Pre Bid Meeting was started on 10.00 am. Purchaser had explained the specifications and the requirements in the tender in detailed. As discussed in the Pre Bid Meeting, The following amendments were made to the conditions in the Bidding Documents with consent of both parties; Bidder and the Purchaser.

 The clause of ITB 4.1 of Bidding Data Sheet is revised as "Apart from the instructions given in the clause, the interested bidder shall have CIDA Grade C-6 or EM 3 SP". (Please see the Annexure – 2)

- The clause of item 5 of 11 e of Bidding Data Sheet is revised as "CIDA Grade C-6 or EM 3 SP" (Please see the Annexure – 2)
- 3. As agreed by both parties, the University (The Purchaser) shall construct the followings;
  - a) The Plinth will be constructed by the university on design provided by the selected bidder. The cost of Plinth shall not be included in the bid.
  - b) The equalization tank shall be designed and constructed by the university in parallel with the installation work of sewerage treatment plant by the selected bidder.
- The university decided to extend the closing of bid as 2.30 pm 20<sup>th</sup> January 2022 considering the request of all the bidders. Therefore, the bidder shall provide the Bid validity and validity of Bid Bond till 30<sup>th</sup> April 2022. (Please see the Annexure 2)
- 5. Following changes are made in the Price Schedule (Please see the Annexure 3)
  - a. 1.03 quantity is 190m
  - b. 2.03 quantity is 4m
  - c. 3.03 quantity is 170m.
