The South Eastern University of Sri Lanka will entertain applications from the suitably qualified candidates for the following posts

01. CURATOR (LANDSCAPE) GR. III

QUALIFICATIONS:

Should possess a four year Special Bachelor's Degree (Honours) in Agriculture or Agricultural Technology & Management and majoring in Crop Science/ Horticulture/ Floriculture/ Forestry from a recognized University/HEI with not less than one (01) year of experience in landscaping in a State/ Corporation or reputed Private sector organization in supervisory capacity.

OR

Should possess a four year Special Bachelor's Degree (Honours) in Landscape Architecture from a recognized University/HEI with not less than one (01) year of experience in landscaping in a State/ Corporation or reputed Private sector organization in supervisory capacity.

OR

Should possess a four year Special Bachelor's Degree (Honours) in Botany from a recognized University/ HEI with not less than two (02) years of experience in landscaping in State/ Corporation or reputed Private sector organization in supervisory capacity.

02. WORKSHOP ENGINEER, GR. III

QUALIFICATIONS:

(a) Should possess a B.Sc. Engineering Degree specializing in Mechanical/Production Engineering from a recognized University/ HEI

OR

(b) Should possess a National Diploma in Technology specializing in Mechanical/ Production Engineering or equivalent qualification, with at least seven (07) years of experience in a Mechanical workshop of a recognized establishment.

NOTE: The in-plant training period shall not be counted for the period of experience

Salary Scale: U-EX I(II) Rs. 85,305 – 3x2,020; 91,365(EB) 93,765; 12x2,400 –122,565 p.m.
(In addition, the Government approved allowances applicable to the university system will be paid)

BENEFITS:

- The selected candidate will become a contributor to the Universities Provident Fund and University Pension Scheme in terms of the existing regulations. The appointee is required to contribute 10% of the monthly salary to the Provident Fund while the employer will contribute a sum equivalent to 15% of that salary of which 08% is credited to the Pension Scheme, 07% to the Provident Fund, and 03% to the Employees Trust Fund.
- Payment of Gratuity will be in accordance with the provisions of the Payment of Gratuity Act. No. 12 of 1983

GENERAL NOTE:

- The appointment will be on probation for a period of three years, which may be extended at the discretion of the Council of the South Eastern University of Sri Lanka. Provided that, where an employee confirmed in the Commission or in a Higher Educational Institution, is subsequently appointed for the said post, in the first instance, for a probationary period of one year, and shall thereafter be subject to confirmation by the Governing Authority of the South Eastern University of Sri Lanka.
- The other conditions of appointment will be in accordance with provisions of the Universities Act and its amendments, Establishment Code of the UGC & HEI's, Ordinance, By-laws, Regulations and Rules, etc. made thereunder.
- Age - Not more than 45 years.
(This age limit will not apply to employees of the University system, employees of Government Departments/Corporations/Statutory Boards)

SELECTION CRITERIA:

- a). Selection by a structured interview.
- b). Applicants who have scored 40% marks or above at the structured interview are eligible to be considered for selection.

OTHER CONDITIONS:

- (i) Applications for the above post should be submitted on the prescribed application form, which can be downloaded from the link on the University website <https://www.seu.ac.lk/vacancy/>.
- (ii) Duly completed applications must be forwarded under **registered cover, together with copies of all relevant certificates, to reach the Registrar, South Eastern University of Sri Lanka, University Park, Oluvil, #32360 on or before 30.09.2026**. Only applications submitted in the specified form will be accepted.
- (iii) In the application, candidates are required to specify the relevant category under which they are applying.
- (iv) Applicants shall pay a non-refundable application fee of Rs. 500.00, and the receipt must be attached to the duly completed application form. **Applicants should pay it to the Account No. 228-1001-9000-1704, People's Bank, Addaichenai, South Eastern University of Sri Lanka Collection Account, through any branch of the People's Bank.**

(v) The name of the post in respect of which the applications are sent, should be stated on the top left hand corner of the envelope.

(vi) Candidates in the service of the University Grants Commission and Higher Educational Institutions/Institutes, Government Departments, State Corporations and Statutory Boards should channel their applications through the Heads of their respective Institutions. Applications which are not forwarded through the respective Heads of Departments will be rejected.

(vii) Applications received after the closing date/not in conformity with the above requirements/ incomplete applications will be rejected without intimation.

(vii) The South Eastern University of Sri Lanka reserves the right to shortlist the candidates.
