RECRUITMENT OF INSTRUCTORS IN ENGLISH TO THE HIGHER EDUCATIONAL INSTITUTIONS/ INSTITUTES

Your kind attention is drawn to Schemes of Recruitment of the post of Instructor in English, Grade III, Grade II, Grade I and Senior Instructor in English given in Commission Circulars No. 403 of 08.09.1989 and No. 437 of 20.04.1990 as amended by Commission Circulars No. 481 of 03.08.1991, No. 497 of 29.10.1991, No. 526 of 03.07.1992 and No. 637 of 24.07.1995, and to Item 05 of paragraph (2) of Establishments Circular Letter No. 05/2005 of 29.03.2005 regarding recruitment prospects of three posts coming under the Academic Support Staff including the post of Instructor in English.

- 2. The Commission at its 957^{th} meeting held on 19.01.2017 having considered the exigencies of service in the Higher Educational Institutions/Institutes, decided to make recruitments to the post of Instructor in English, as early as possible.
- 3. The Scheme of Recruitment to be followed in making new recruitments to the post of Instructor in English Grade III, along with the promotional grades of Instructor in English Grade II, Grade I and Senior Instructor in English, is given in **Annex I**.
- 4. Accordingly, the previous and the existing Schemes of Recruitment and Promotion of the post of Instructor in English, and Commission Circulars No. 437, No. 481, No. 526 and No. 637, are hereby rescinded subject to the condition that provisions of the Commission Circulars No. 437 and 526, if necessary, could be made applicable only for the present holders of the post of Instructor in English who were recruited in 2004 or prior to that, if any.
- 5. The provisions of this circular will come into operation from July 3, 2017.
